

## New working Procedures by MGM Boats for annual service and lift out

## May 18<sup>th</sup> 2020 until further notice

1 **Upon pick up of client boat from marina**. The wheel/ tiller, entry hatch, battery switches, companion way handles, and any **touched surface**, are cleaned with disinfectant wipes.

2/ Upon lift out for and during wash. Only 1 MGM staff under boat as per our normal safety procedures.

3/ <u>Sitting boat to cradle</u>. Only 1 MGM staff under boat and 1 MGM Staff on crane remote as per our normal safety procedures. Having a dedicated marine travel hoist enables one operator and one crew member to achieve this.

4/ Antifouling. Only 1 MGM Staff applying paint as per our normal safety procedures at any one time.

5/ Anodes changing. Only 1 MGM staff member fitting anodes as per our normal safety procedures

6/ Polish hull. Only 1 MGM staff applying and polishing hulls as per our normal safety procedures

7/ Lift back in. Only 1 MGM staff operating crane as per our normal safety procedures and 1 MGM staff on board to deliver yacht back to marina when coming out of dock area.

8/ Upon leaving yacht back on marina. 1 MGM Staff will secure the boat, shut down batteries and secure hatch. All areas to be disinfected as per procedure 1 above. 1 MGM staff member will be on ponton to assist securing lines.

9/ Keys for yachts. Individual arrangements will be made to collect keys. All keys will be wiped down with disinfectant wipes after use also.

10/ <u>All other engineering works.</u> All other works will have a discussion beforehand in order to establish a safe working distance and this will be done at each morning meeting, where clear instructions will be issued.

11/ All clients will be informed before and after each service by email outlining the works carried out

<u>All our staff have been provided with the appropriate training as per above procedures and all protective</u> <u>equipment has been issued to ensure a safe working environment.</u>
